NYS Archives and Library Reopen Monday, May 17

We're glad to share some great news—the Cultural Education Center (CEC) will reopen to the public on Monday, May 17 at 10:00 am.

The new, temporary hours for the Museum, Archives, and Library will be Monday through Friday, 10:00 am–4:00 pm. The CEC will be closed on Saturdays and Sundays to the public until further notice and on all state-observed holidays.

The CEC has taken precautions for visitor safety in accordance with New York State and CDC COVID-19 practices and restrictions:

- Masks will be required for visitors over the age of two.
- Capacity per institution, floor, and/or gallery will be limited to allow for safe social distancing.
- The Museum will not be scheduling or allowing tour groups of more than 10 individuals until further notice.

The CEC Reopen team consisting of Library, Archives, and Museum staff have done an outstanding job preparing spaces, and online reservation systems for the visitors.

Per COVID-19 restrictions, visitors to the Museum and Library should make reservations online or by phone to schedule admission. Walk-in

admission will be available only as space allows.


